I, Detective David J. Madden, the Affiant, being first duly sworn, upon oath, deposes and says:

That I am a duly sworn and authorized peace officer for the City of Norman, County of Cleveland, and State of Oklahoma and was acting in that capacity at all times mentioned herein.

On 10-22-2017 management at the Emerald Green Apartments located at 2815 Dewey Ave, Norman Ok reported that someone had broken into their maintenance shop. The burglary occurred between the evening of 10-20-2017 and the morning of 10-22-2017. Management advised the defendant was a possible suspect. The defendant is an ex-employee who worked in maintenance, but had recently been let go. The defendant still lives on the property.

Forced entry had been made and several tools were taken. Management was able to provide a detailed list of those items. The defendant pawned two of the tools at the Pawn Plus on N. Porter in Norman on 10-21-2017 and received \$35.00 for those items, claiming ownership for 2 years. The defendant then pawned the remaining tools at Express Cash Pawn on N. Macarthur in OKC on 10-22-2017. He received \$320 dollars for those tools, and claimed ownership for 1 month. Management valued to stolen tools at over \$1000 dollars to replace.

I was able to interview the defendant on 11-1-2017. He at first denied pawning the items and then admitted to pawning them. He denied stealing the items, saying that the maintenance supervisor gave him the tools as payment for work done.

Based on the foregoing facts, your Affiant prays that this honorable court issue a finding of fact that probable cause exists to believe that the crime(s) **False Declaration of Ownership in a Pawn O.S. § 59-1512 x 2 and Criminal Patterning O.S. § 21-425** have occurred within the City of Norman, County of Cleveland, State of Oklahoma. Further that the said offense(s) was/were committed by the defendant, contrary to the law and against the peace and dignity of the State of Oklahoma. Your Affiant requests that the Court issue a warrant for the arrest of **DEFENDANT**. Your Affiant swears and affirms that the above information is true and correct. Further your Affiant sayeth not.
