That the AFFIANT is employed by the Norman Police Department. That on or about the **9th** day of **November 2017**, at **901 N. Porter Ave, Norman 73071**, Cleveland County, Oklahoma, the undersigned further states as follows:

I was dispatched to relieve a night shift officer at Norman Regional Hospital. The defendant was in custody receiving a Fit Slip in the ER. Master Police Officer Slater and I noticed the defendant was hand cuffed with his left hand to the rail of the hospital bed. The defendant stood up and walked around on the other side of the bed and became unruly. Master Police Officer Slater instructed the defendant to sit back down and the defendant disobeyed commands. Master Police Officer Slater and I sat the defendant back on the bed. The defendant kicked at Master Police Officer Slater's face and grabbed his wrist. The defendant grabbed my wrist while yelling profanities and threats. I placed the defendant under arrest at about 1018 hours for assault and battery on a Police Officer. The defendant was transported to Cleveland County Detention Center and booked in.

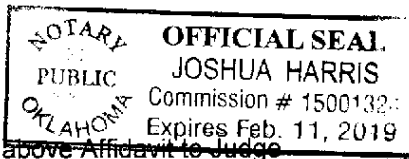
