2017, AT 201-B W. GRAY NORMAN

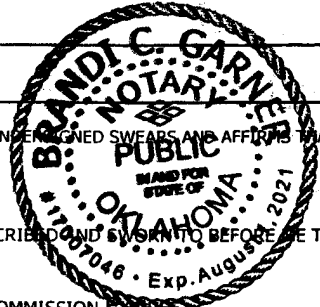
CLEVELAND COUNTY, OKLAHOMA, THE UNDERSIGNED FURTHER STATES AS FOLLOWS:
